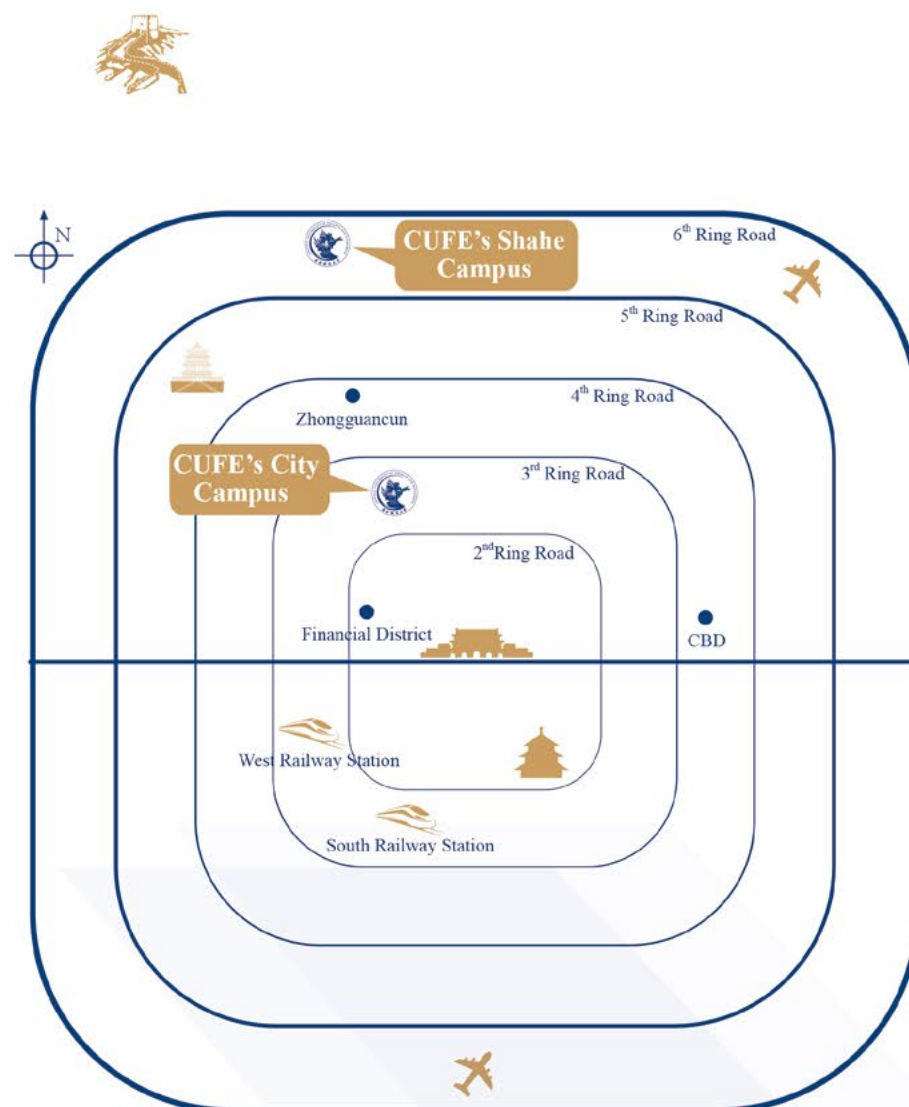

## UNIVERSITY PROFILE

In 1949, shortly after the founding of the People's Republic of China, Central University of Finance and Economics (CUFE) was founded in Beijing by the central government. It was the first institution in China to provide systematic training to government officials in the economics and finance sector.

As one of China's key universities under the direct leadership of the Ministry of Education, CUFE enjoys the patronage of both the central and municipal governments. CUFE's status as a center of academic excellence was again recognized with our selection to Project 211, the national education project in which at the beginning of the 21st century 100 top universities of China were selected. In September 2017, CUFE's applied economics has been designated world first-class discipline by the Ministry of Education.

CUFE has developed into a key resource for first-class personnel in all areas of economics and management as well as offering comprehensive education in law, liberal arts, and science.

### Insurance & Actuarial Science

CUFE is the first university in China to be accredited by the Institute and Faculty of Actuaries, Britain (IOA)’s CT1-8. Insurance majors automatically qualify for memberships to the Australian and New Zealand Institute of Insurance and Finance (ANZII). CUFE’s School of Insurance is considered top 3 in Asia. CUFE’s China Institute for Actuarial Science is a national research base.

### MPAcc

The MPAcc (Professional Master of Accounting) program is among the first in China to be classified as a level-A institution by AAPEQ

### MBA

The MBA program is accredited by Association of MBAs (AMBA). CUFE is the eighth institution in China and the first in Beijing to be accredited by AMBA.

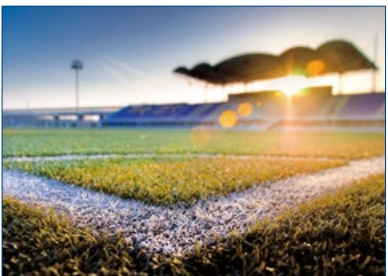

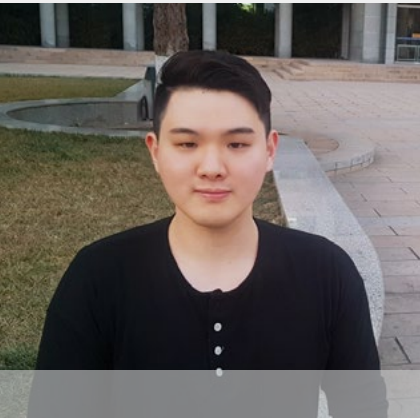
## Technology Hub

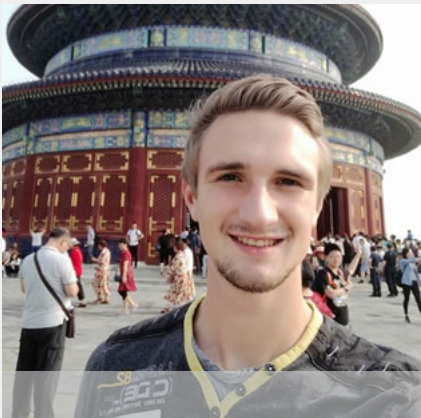

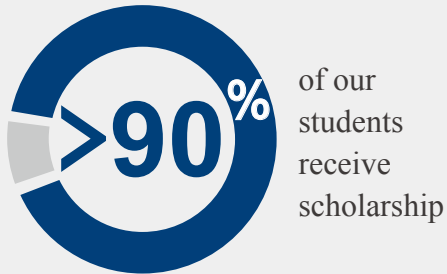

- A letter of guardianship
- A copy of guardian’s passport or ID

**Application Fee**

A 500 RMB application fee must be made payable to the School.  
Application fee is **non-refundable**.

**Deadline**

R1 deadline: March 28th, 2018  
R2 deadline: May 31st, 2018  
The admission at CUFE is conducted on a rolling basis. Therefore it is strongly recommended that applications be submitted as early as possible. Early applicants will also gain an advantage in scholarships and housing application.

**Processing**

Once all documents have been received, your application will be forwarded to according academic departments for further review. Applicants will be notified via e-mail regarding interview information and admission results.

**Deposit Fee**

A 3000 RMB deposit fee has to be paid within 2 weeks of your admission. It will be deducted from your tuition fee upon enrollment.

Note: All application documents will NOT be returned regardless of your admission status.
